Based on the provision of Article 5 of the Decision on the Organization and Functioning of Regional Coalitions and Article 26 of the Statute of the International cancer patients coalition, the Founder of the International cancer patients coalition, on July 27<sup>th</sup>, 2024, adopts the following:

## **DECISION ON THE ESTABLISHMENT OF THE REGIONAL COALITION Asia Pacific Cancer Patient Coalition**

### **Article 1.**

This Decision establishes a Regional Coalition integrated within the International cancer patients coalition under the name of Regional Coalition Asia Pacific Cancer Patient Coalition which will operate in the Asia Pacific regions under the name *Asia Pacific Cancer Patient Coalition*.

### **Article 2.**

The Regional Coalition will consists of a minimum of 3 members elected from among patients, healthcare professionals, representatives of organizations, and other relevant stakeholders.

Through multi-stake holder collaborative partnerships in on an unprecedented scale, the regional coalition aspires to create a unified group that accelerates breakthroughs so that patients can live their best lives in a timely manner, and ensuring that our patient centered innovative therapies and diagnostics positively impact diverse populations everywhere closer to where they live

### **Article 3.**

This Decision is an integral part of the Decision on the Organization and Functioning of Regional Coalitions.

The Statute of the International cancer patients coalition, decisions, and regulations of the


International cancer patients coalition apply to the activities and operations of the Asia Pacific Cancer Patient Coalition unless otherwise specified by this Decision or another special decision.
